WHEREAS, the Sheriff Office has been awarded grant funds by the Missouri Department of Transportation, Highway Safety and Traffic Division for hazardous moving violation enforcement in

the amount of \$26,000.00; and,

WHEREAS, the grant funds will be used to conduct enforcement actions in order to decrease speed, hazardous driving related injuries, and fatality crashes; and,

WHEREAS, the Sheriff's Office recommends the acceptance of this award and the execution of a contract with the Missouri Department of Transportation, Highway Safety and Traffic Division; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; now therefore,
