A RESOLUTION authorizing the County Executive to execute a Cooperative Agreement with Truman Medical Center Behavioral Health Services, a division of Truman Medical Center, Inc., to provide for a substance abuse treatment program for inmates of the Jackson County Detention Center, at a cost to the County not to exceed \$132,125.00.

WHEREAS, by Resolution 15708, dated November 28, 2005, the County did authorize the County Executive to execute a Cooperative Agreement with Truman Medical Center Behavioral Health Services, a division of Truman Medical Center, Inc., at a cost to the County not to exceed \$281,205.00, to provide for a substance abuse treatment program for inmates of the Jackson County Detention Center, with an option to renew the contract for the 2007 fiscal year at an agreed-upon rate; and,

WHEREAS, the Director of Corrections now recommends a renewal of the contract with Truman Medical Center Behavioral Health Services, a division of Truman Medical Center, Inc., at a cost to the County not to exceed \$132,125.00, for the 2007 fiscal year as outlined in the attached Cooperative Agreement; now therefore,
