## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** transferring \$21,761.00 within and appropriating \$217,605.00 from the fund balance of the 2008 Anti-Drug Sales Tax Fund in acceptance of a grant from the Missouri Department of Public Safety, and authorizing the County Executive to execute Cooperative Agreements with Arts Tech and Deana Bellamaganya for the Prosecuting Attorney's Office's Sentenced to the Arts program, at an aggregate cost to the County not to exceed \$217,605.00.

## **ORDINANCE #4054**, October 20, 2008

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, the Missouri Department of Public Safety has awarded the County a grant in the amount

of \$195,844.00, a portion of which is to be used to fund the Prosecuting Attorney's Sentenced to the

Arts program; and,

WHEREAS, this program provides expressive therapy programs and services to adjudicated youth; and,

WHEREAS, the Prosecuting Attorney's Office recommends Cooperative Agreements with Arts Tech (\$149,575.00), which will provide oversight and implementation of the program, and Deana Bellamaganya (\$68,030.00), who will manage and direct the program; and,

WHEREAS, the cost of this portion of the Sentenced to the Arts program is \$217,605.00, which

includes a local match of \$21,761.00, for which a transfer and appropriation are necessary; and,

WHEREAS, the County Executive recommends said appropriation and transfer; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer within and appropriation from the fund balance of the 2008 Anti-Drug Sales Tax Fund be and hereby are made:
