AN ORDINANCE appropriating \$50,000.00 from the fund balance of the 2011 Grant Fund in acceptance of additional grant funds from the Family Court Division's Juvenile Court Diversion Program grant awarded by the State of Missouri Division of Youth Services.

WHEREAS, by Ordinance 4278, dated December 16, 2010, the Family Court Division was awarded a grant in the amount of \$292,967.40 for the Juvenile Court Diversion Program by the State of Missouri Division of Youth Services, for the period of July 1, 2010, through June 30, 2011; and,

WHEREAS, the Division of Youth Services now desires to award additional funds in the amount of \$50,000.00, to expand the scope of the program to include a demonstration project called Parenting with Love and Limits, which combines parent education and group therapy with individual coaching sessions for adolescents and their parents; and,

WHEREAS, the grant does not require local matching funds; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,
