## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** awarding a thirty-six month term and supply contract for the lease of vehicles for use by the Jackson County Drug Task Force to Lifestyle Leasing, Inc., of North Kansas City, MO, as a sole source purchase.

WHEREAS, the County desires to lease vehicles for use by the Jackson County Drug Task Force; and,

WHEREAS, section 1030.1, <u>Jackson County Code</u>, eliminates the requirement for competitive bidding when items or services to be purchased can be obtained from only one source and requires notification of and approval by the Legislature on such sole source purchases exceeding \$25,000.00; and,

WHEREAS, the officer in charge of the Drug Task Force has advised that, due to the unique needs of the Task Force for confidentiality and other law enforcement requirements, Lifestyle Leasing is the sole provider of leased vehicles on terms meeting the Task Force's needs in the Kansas City metropolitan area; and,

WHEREAS, the Director of Finance and Purchasing recommends the lease of vehicles from
