A RESOLUTION awarding a contract for the furnishing of evaluation services for use by COMBAT to the Curators of the University of Missouri - Columbia, under the terms and conditions of Request for Proposals No. 73-11, at a cost to the County not to exceed \$15,723.18.

WHEREAS, COMBAT requires evaluation services on its prevention programs to assure the effectiveness of the programs; and,

WHEREAS, the Director of Finance and Purchasing solicited formal written bids on Request for Proposals No. 73-11 for these services; and,

WHEREAS, a total of twenty-two notifications were distributed and five responses were received and evaluated as follows:

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the award be made as recommended by the Director of Finance and Purchasing, and that the Director be, and is hereby, authorized to execute for the County any documents necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment, on the contract.
