## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** transferring \$50,051.00 within the 2013 Anti-Drug Sales Tax Fund to cover funding for the Sheriff's Office's 2013 Drug Abuse Resistance Education (DARE) program.

**RESOLUTION NO. 18105, February 25, 2013** 

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, COMBAT staff recommends that \$50,051.00 in Anti-Drug Sales Tax Funds be allocated to the Sheriff's Office's 2013 Drug Abuse Resistance Education (DARE) program representing one-half of the 2013 allocation for DARE, with the balance to be transferred mid-year subject to available revenues; and,

WHEREAS, at its meeting of February 13, 2013, the Drug Commission endorsed staff's recommendation in this regard; and,

WHEREAS, a transfer within the 2013 Anti-Drug Sales Tax Fund is necessary to cover this program; and.

WHEREAS, the County Executive has recommended said transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer
