AN ORDINANCE appropriating \$187,764.00 from the undesignated fund balance of and transferring \$62,588.00 within the 2013 Anti-Drug Sales Tax Fund in acceptance of the 2013 Edward Byrne Memorial Justice Assistance Grant awarded to the Multi-Jurisdictional Drug Task Force.

ORDINANCE NO. 4545, July 15, 2013

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the U.S. Department of Justice, Office of Justice programs, has awarded the Multi-Jurisdictional Drug Task Force an Edward Byrne Memorial Justice Assistant Grant (JAG) in the amount of \$187,763.75 for the period July 1, 2013, through June 30, 2014; and,

WHEREAS, the JAG program is administered by the Missouri Department of Public Safety; and,

WHEREAS, the grant proceeds will be used to partially fund the salaries and benefits of a forensic chemist and three deputies; and,

WHEREAS, the JAG grant is subject to a local match in the amount of \$62,587.91; and,

WHEREAS, an appropriation and transfer are necessary in order to place the grant and matching funds in the proper spending accounts; and,
