WHEREAS, the Parks + Rec Department has a need for marine supplies and accessories for resale at County-owned marinas; and,

WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 32-14 for the furnishing of marine supplies and accessories for resale at County-owned marinas by the Parks + Rec Department to provide for departmental needs for the upcoming twenty-four month period, with three twelve-month options to extend; and,

WHEREAS, a total of twenty-three notifications were distributed and one response was received as follows:

WHEREAS, the Director of Finance and Purchasing recommends that the contract be awarded to

Medart Marine of Edwardsville, KS, as the lowest and best bidder; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay

any specific amount, with the availability of funds for specific purchases subject to annual

appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

recommended by the Director of Finance and Purchasing, and that the Director be and hereby is

authorized to execute for the County any documents necessary for the accomplishment of the award;

and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to make all payments on the contract, including final payment, to the extent that sufficient

appropriations to the using spending agencies are available in the then current Jackson County

budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the

Legislature.
