WHEREAS, the Director of Public Works recommends that the contract be awarded to Vance

Brothers, Inc., for the reason that it has submitted the lowest and best bid; and,

WHEREAS, the County reserves the right to adjust the quantities up or down to the bid to

accommodate available funds within the bid specifications; and,

WHEREAS, in the event that line item adjustments to the contract become necessary, it is

appropriate that the Director of Public Works be authorized to approve said line item adjustments to

the extent there is no additional cost to the County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the award be made

as recommended by the Director of Public Works and that the County Executive be and hereby is

authorized to execute any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Public Works be and hereby is authorized to make

adjustments in the contract line item quantities to the extent that there will be no further funding

obligation to the County; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contract.
