## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay

any amount, with the availability of funds for specific purchases remaining subject to annual

appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the award be made

as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is

authorized to execute for the County any documents necessary to the accomplishment of the

purchase; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payments on the contracts, to the extent that sufficient appropriations are

contained in the then current Jackson County budget.
