WHEREAS, by Resolution 18541, dated June 9, 2014, the Legislature did award a twelve-month contract with one twelve-month option to extend, on Request for Proposals No. 45-14 to John Q. Ebert and Associates Consulting, LLC, of Bluffton, OH, for the furnishing of a highly-qualified, experienced consultant with assessor experience, at an initial cost to the County of \$40,000.00; and,

WHEREAS, by Resolution 18624, dated October 6, 2014, the Legislature did authorize an addendum to the Consulting Agreement with John Q. Ebert and Associates Consulting to assist with the County's 2015 reappraisal process at an additional cost to the County not to exceed \$60,000.00; and,

WHEREAS, the Assessment Department desires to extend the Agreement with Ebert and Associates, at an additional cost to the County not to exceed \$270,000.00; and,
