IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION transferring \$44,983.00 within the 2015 Anti-Drug Sales Tax Fund to cover funding for the Sheriff's Office's 2015 Drug Abuse Resistance Education (DARE) program.

RESOLUTION NO. 18790, April 13, 2015

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, COMBAT staff recommends that \$44,983.00 in Anti-Drug Sales Tax Funds be allocated to the Sheriff's Office's 2015 Drug Abuse Resistance Education (DARE) program representing one-half of the 2015 allocation for DARE, with the balance to be transferred mid-year subject to available revenues; and,

WHEREAS, at its meeting of March 10, 2015, the Drug Commission endorsed staff's recommendation in this regard; and,

WHEREAS, a transfer within the 2015 Anti-Drug Sales Tax Fund is necessary to cover this program; and.

WHEREAS, the County Executive has recommended said transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer

be made within the 2015 Anti-Drug Sales Tax Fund:
