WHEREAS, sponsorship of this event will promote COMBAT's "Don't Look the Other Way" anti-violence initiative; and,

WHEREAS, said sponsorship is in the best interest of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of Finance and Purchasing be and hereby is authorized to issue a check to the Kansas City Pythons Drill Team, in the amount of \$500.00 for sponsorship of the Planet Rock Drill Team competition to be held April 11, 2015.
