A RESOLUTION authorizing the County Counselor to settle the employment claims of Lisa McGhee for the total payment by the County of \$58,500.00.

RESOLUTION NO. 18836, May 18, 2015

INTRODUCED BY Dan Tarwater III, County Legislator

WHEREAS, County employee Lisa McGhee has filed a charge of employment discrimination with the Missouri Commission on Human Rights in which she has alleged that certain conduct and/or conditions she experienced during her employment violated her right to be free from discrimination in the workplace; and,

WHEREAS, although the County denies any discrimination, after a thorough investigation and negotiations, the County Counselor recommends a settlement in the amount of \$58,500.00, in exchange for the full and complete release of all claims, to be paid to Ms. McGhee and her attorney, Martin Meyers; and,

WHEREAS, the proposed settlement will limit the County's financial obligation in this matter and is in the best interest of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the settlement of the claims of Lisa McGhee, as recommended by the County Counselor, be and hereby is approved; and,
