IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$1,398.00 from the undesignated fund balance of the 2015 Health Fund in acceptance of insurance proceeds for the repair of a vehicle for use by the Public Works Department.

WHEREAS, the County has received a payment from Shelter Mutual Insurance Company representing the repair cost of a fleet vehicle assigned to the Environmental Health Division of the Public Works Department, damaged as a result of a motor vehicle accident that occurred on June 12, 2015; and,

WHEREAS, an appropriation is necessary to place the insurance payment in the proper spending account so that the funds may be used to repair the vehicle; now therefore,
