## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** transferring \$12,850.00 within the 2015 Grant Fund and authorizing the County Executive to execute an Amendment to the Agreement with the Missouri Department of Transportation for the Sheriff's Office's DWI Traffic Safety Unit Salary Grant, at no additional cost to the County.

WHEREAS, by Ordinance 4662, dated September 15, 2014, the Legislature did authorize the acceptance of a grant in the amount of \$160,255.00 from the Missouri Department of Transportation for the Sheriff's Office's DWI Traffic Safety Unit Salary Grant, for the period October 1, 2014, through September 30, 2015; and,

WHEREAS, the Missouri Department of Transportation has authorized an amendment to the budget for the grant award to allow \$12,850.00 of grant funds to be used for an additional uniform allowance and pension funds, at no additional cost to the County; and,

WHEREAS, a transfer is necessary in order to place these funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer; now therefore,
