WHEREAS, pursuant to section 1030.4 of the <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing recommends the award of a contract for this equipment to Government Scientific Source, Inc. of Reston, VA, at a cost to the County not to exceed \$110,684.00, under the terms and conditions set forth in GSA Contract No. GS-07F-5934R, an existing government contract; and,
