WHEREAS, Faith Bible College has submitted a request for sponsorship of this event in the amount of \$1,500.00; and,

WHEREAS, this conference's goal is to dispel myth and stigma for people of faith seeking professional mental health and addiction services; and,

WHEREAS, this sponsorship will allow Jackson County the opportunity for regional recognition of its anti-drug and anti-violent crime initiatives; and,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of Finance and Purchasing be and hereby is authorized to issue a check to Faith Bible College, in the amount of \$1,500.00 for sponsorship of the *ReMade* conference.
