IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the execution of a Cooperative Agreement with the Peer Court of Southeast Jackson County for the furnishing of anti-drug and violent crime prevention activities, at a cost to the County for 2015 in the amount of \$30,000.00 and at a total cost to the County not to exceed \$90,000.00.

WHEREAS, the Jackson County Drug Commission has recommended an agreement with the Peer Court of Southeast Jackson County for anti-drug and anti-violent crime prevention and diversion services to students of school districts located in southeast Jackson County; and,

WHEREAS, the total cost of this new diversion program is \$90,000.00, with \$30,000.00 allocated from the 2015 budget and the remaining \$60,000.00 subject to appropriation in the 2016 budget; and,

WHEREAS, a Cooperative Agreement with the Peer Court of Southeast Jackson County for the furnishing of this program is in the best interests of the health, safety, and welfare of the citizens of Jackson County; now therefore,
