### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** transferring \$5,000.00 within the 2016 Health Fund and authorizing the execution of an Addendum to the Cooperative Agreement with One Good Meal for the furnishing of meals to senior citizens and homebound individuals, at an additional cost to the County not to exceed \$5,000.00.

**RESOLUTION NO. 19119**, April 4, 2016

**INTRODUCED BY** Dennis Waits and Theresa Galvin, County Legislators

WHEREAS, by Resolution 19043, dated January 19, 2016, the Legislature did authorize a Cooperative Agreement with One Good Meal of Lee's Summit, MO, for the furnishing of meals to senior citizens and homebound individuals, at a cost to the County in the amount of \$20,000.00; and,

WHEREAS, it is now recommended that the allocation of funds for this program be increased in the amount of \$5,000.00; and,

WHEREAS, a transfer is needed to place the additional funds needed for this program in the proper spending account; and,

WHEREAS, the County Executive recommends this transfer; now therefore,

**BE IT RESOLVED** by the County Legislature of Jackson County, Missouri, that the following transfer

be made within the 2016 Health Fund:
