WHEREAS, a Cooperative Agreement with the OK Program for a violent crime prevention program at a cost to the County in the amount of \$16,000.00 is in the best interests of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute a Cooperative Agreement with the OK Program for the furnishing of a violent crime prevention program, in the amount of \$16,000.00, in a form to be
