WHEREAS, by Request for Qualifications (RFQ) No. 75-15, the Director of Finance and Purchasing did solicit the submission of qualifications from firms interested in providing financial advisory services to the Finance and Purchasing Department; and,

WHEREAS, the proposals submitted were evaluated on the basis of responsiveness to the scope of

services, qualifications, experience, approach, and references; and,

WHEREAS, following evaluation of the proposals, the Director of Finance and Purchasing has

recommended the award of a contract with two twelve-month options to extend for these services to

Ameritas Investment Corporation of Kansas City, Missouri; and,

WHEREAS, the Director of Finance and Purchasing recommends that the award be made pursuant

to section 1054.6 of the Jackson County Code, 1984, to Ameritas Investment Corporation of Kansas

City, MO, at a cost to the County not to exceed \$25,000.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive

be and hereby is authorized to execute for the County an Agreement with Ameritas Investment

Corporation, in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to make all payments, including final payment on the contract.
