AN ORDINANCE appropriating \$4,992.00 from the undesignated fund balance of the 2016 Special Road and Bridge Fund in acceptance of insurance proceeds for the repair of a vehicle for use by the Public Works Department.

WHEREAS, the County has received a payment from Esurance Property & Casualty Insurance Company representing the repair cost of a Public Works Department fleet vehicle damaged as a result of a motor vehicle accident that occurred on July 5, 2016; and,
