A RESOLUTION awarding a contract on Bid No. 09-2016 for the Longview Lake Multi-Purpose Trail Renovation, Project No. 3204 to Orr Wyatt Streetscapes, of Raytown, MO, at an actual cost to the County not to exceed \$218,301.00, and authorizing the Director of Public Works to approve line item adjustments under this contract at no additional cost to the County.

WHEREAS, by Resolution 18652, dated November 3, 2014, the Legislature did authorize the execution of a Memorandum of Agreement with the Eastern Federal Lands Highway Division and the Missouri Highways and Transportation Commission relating to a grant under the Federal Lands Access Program for improvements to the Longview Lake Trail; and,

WHEREAS, by Ordinance 4827, dated February 29, 2016, the Legislature did appropriate funds in acceptance of the Federal Lands Access Program Grant awarded by the Missouri Highways and Transportation Commission for the Longview Lake Multi-Purpose Trail Renovation Project; and,

WHEREAS, the Director of Public Works has solicited formal written bids on Bid No. PW 09-2016 for the Longview Lake Multi-Purpose Trail Renovation, Project No. 3204; and,
