WHEREAS, by Resolution 18987, dated November 4, 2015, the Legislature did authorize the execution of a Memorandum of Understanding (MOU) with the Communications Workers of America, AFL-CIO Local 6360 (CWA), regarding the terms and conditions of employment of certain associates within the Jackson County Sheriff's Office in the position of dispatcher (Communications Specialists); and,

WHEREAS, article 21, section 2 of the MOU requires the parties to meet and confer for the purpose of reaching agreement as to compensation upon request of either party; and,

WHEREAS, after negotiation, the parties have agreed to new job and salary classifications for 2017 and future years; and,

WHEREAS, the Sheriff concurs in this proposal and recommends the execution of a Letter of Agreement related to salary increases for members of the bargaining unit, subject appropriation in
