**AN ORDINANCE** appropriating \$7,500.00 from the undesignated fund balance of the 2017 Anti-Drug Sales Tax Fund and authorizing the County Executive to execute an agreement in acceptance of additional funding provided by the Organized Crime Drug Enforcement Task Force for use by the Jackson County Drug Task Force for "Operation Deja Vu."

WHEREAS, by Ordinance 4945, dated December 5, 2016, the Legislature did authorize the acceptance of a grant provided by the Organized Crime Drug Enforcement Task Force (OCDETF) to conduct a joint federal drug investigation in conjunction with the Jackson County Drug Task Force, OCDETF Case No. WC-KC-199, Operation Deja Vu, for the period of November 7, 2016, through September 30, 2017; and

WHEREAS, the OCDETF has authorized additional funding for the reimbursement of overtime related to this operation, in the amount of \$7,500.00; and,

WHEREAS, an appropriation is necessary to place the additional funds in the proper spending account; now therefore,
