IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the County Executive to execute addenda to the Cooperative Agreements with First Call, Healing House, and Synergy Services for the furnishing of drug treatment and/or prevention programs for use by COMBAT, at an aggregate additional cost to the County not to exceed \$50,000.00.

RESOLUTION NO. 19504, June 5, 2017

INTRODUCED BY Dan Tarwater III, County Legislator

WHEREAS, by Resolution 19396, dated February 27, 2017, the Legislature did authorize the execution of Cooperative Agreements with First Call, at a cost to the County not to exceed \$75,000.00, and Healing House, at a cost to the County not to exceed \$135,000.00, to provide antidrug treatment programs; and,

WHEREAS, by Resolution 19434, dated March 27, 2017, the Legislature did authorize the execution of a Cooperative Agreement with Synergy Services for the furnishing of anti-drug and anti-violent crime prevention services, at a cost to the County not to exceed \$37,000.00; and,

WHEREAS, at its meeting on May 9, 2017, the Drug Commission recommended increases to these Cooperative Agreements in the amounts indicated:
