IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE transferring \$8,093.00 within and appropriating \$68,576.00 from the fund balance of the 2017 Anti-Drug Sales Tax Fund in acceptance of additional funds for the Victims of Crime Act Grant for use by the Prosecuting Attorney's Office's Victim Services Program.

ORDINANCE NO. 5000, August 14, 2017

INTRODUCED BY Dan Tarwater III, County Legislator

WHEREAS, by Ordinance 4845, dated May 23, 2016, the Legislature did authorize the acceptance

of the Victims of Crime Act Grant for use by the Prosecuting Attorney's Office; and,

WHEREAS, the Prosecuting Attorney's Office has been awarded additional grant funds in the amount of \$60,482.85 by the Missouri Department of Public Safety for the Office's Victim Services Program for the period April 1, 2017, through September 30, 2017; and,

WHEREAS, the grant will cover partial funding for the salary, benefits, and training costs for three Victim Advocates; and,

WHEREAS, an additional match of \$8,092.50 is required for this grant; and,

WHEREAS, a transfer and appropriation are necessary in order to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer within and appropriation from the undesignated fund balance of the 2017 Anti-Drug Sales Tax Fund
