AN ORDINANCE appropriating \$199,996.00 from the undesignated fund balance of the 2018 Special Road and Bridge Fund and authorizing the County Executive to execute Change Order No. 2 to the 2018 Pavement Maintenance Phase -1 Asphalt Overlay contract with Superior Bowen Asphalt Company, to complete the improvements to Ponca Drive and Slaughter Road, at a cost to the County not to exceed \$199,996.00.

WHEREAS, by Resolution 19804, dated April 2, 2018, the Legislature did award a contract to Superior Bowen Asphalt Company for the 2018 Pavement Maintenance Project, No. 3223; and,

WHEREAS, the Director of Public Works now recommends Change Order No. 2 to the Agreement with Superior Bowen to complete improvements to Ponca Drive and Slaughter Road, at an additional cost to not exceed \$199,996.00; and,

WHEREAS, an appropriation is necessary to place the Funds needed to complete these improvements in the appropriate spending account; now therefore,
