A RESOLUTION authorizing the purchase of a bucket truck for use by the Parks + Rec Department from Time Manufacturing Company of Waco, TX, under the terms and conditions of Sourcewell Contract No. 012418-TIM, an existing competitively bid contract, at an actual cost to the County of \$106,039.00.

WHEREAS, the Parks + Rec Department has a need for a bucket truck to replace an existing truck that has exceeded its useful life; and,

WHEREAS, the model of bucket truck that has been chosen has expanded capabilities, reducing the need for rentals and will be an asset for other departments to utilize; and,

WHEREAS, the Parks + Rec Department has requested the use of Sourcewell (NJPA) contract with Time Manufacturing Company, the manufacturer of the bucket truck, and the use of the Sourcewell (formerly NJPA) contract would provide better pricing by purchasing directly from the manufacturer as well as a large quantity discount; and,

WHEREAS, pursuant to section 1030.4 of the Jackson County Code, the Director of Finance and Purchasing recommends the purchase of the needed bucket truck from Time Manufacturing
