AN ORDINANCE appropriating \$5,966.00 from the undesignated fund balance of the 2020 Park Fund in acceptance of insurance proceeds for the repair of damage to a light pole at the Longview Horse Park.

WHEREAS, the County has received a payment from West Bend Insurance Company, representing the cost of repairs to a light pole at the Longview Horse Park, damaged by a patron who hit the light pole with her horse trailer; and,

WHEREAS, an appropriation is necessary to place the insurance proceeds in the proper spending account so that the funds may be used toward the repair of the damage; now therefore,
