A RESOLUTION awarding a twelve-month term and supply contract with one twelve-month option to extend for the furnishing of office furniture for use by various County departments to Office Product Alliance of Kansas City, MO, and Interior Landscapes of Kansas City, MO, under the terms and conditions of Invitation to Bid No. 33-20.

WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 33-20 for the furnishing of office furniture for use by various county departments to provide for departmental needs; and,

WHEREAS, a total of thirty-two notifications were distributed, and three responses were received as follows:

<u>Vendor</u>	<u>Discount on Sample Bid Items</u>
Office Products Alliance Kansas City (Jackson County), MO	57%
Interior Landscapes Kansas City (Jackson County), MO	55%
Scott Rice Office Lenexa, KS	55%

and,

WHEREAS, following evaluation of the bids submitted, the Director of Finance and Purchasing recommends that the contract award be split between Office Product Alliance of Kansas City (Jackson County), MO, and Interior Landscapes of Kansas City (Jackson County), MO, for the reason that they have submitted the lowest and best bids; and,

WHEREAS, the Director recommends a spilt award to allow County departments additional options to match furniture already in place and a broader selection of new furniture; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be, and hereby is, authorized to execute for the County any documents necessary to the accomplishment of the award and any extensions; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contract, to the extent that sufficient appropriations to the using spending agencies have been made in the then current Jackson County budget.
