IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE granting a conditional use permit (CUP) in District RU (Residential Urban) for a period of five years to operate a bed and breakfast inn (Airbnb), subject to specified conditions, as to a .48 ± acre tract.

ORDINANCE NO. 5432, October 19, 2020

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. A conditional use permit is hereby granted for a period of five years to operate a bed and breakfast inn (Airbnb), as to an approximate .48 <u>+</u> acre tract of land commonly known as 9518 Lotawana Drive, Jackson County, MO, and specifically described as follows:

Description: Lot 10, Storms Center, a subdivision in Jackson County, Missouri

<u>Section 2</u>. The conditional use permit for a period of five years granted by this Ordinance is subject to the following conditions:

- The bed and breakfast inn (Airbnb) is limited to no more than one bedroom for temporary lodging for transient guests on a paying basis.
- 2) Cooking facilities shall not be permitted in individual guest rooms.
- In addition to required residential parking, one off-street parking space shall be provided for each guest room.
- 4) One identification/directional sign, not to exceed eight (8) square feet in area, may be
