AN ORDINANCE appropriating \$52,412.00 from the undesignated fund balance of the 2020 Grant Fund in acceptance of an increase to the Gender Specialized Tracker Program Grant received from the Missouri Department of Public Safety.

ORDINANCE NO. 5457, November 23, 2020

WHEREAS, the Family Court Division has been awarded an increase to its Gender Specialized Tracker Program grant in the amount of \$52,412.00 by the Missouri Department of Public Safety for the extended period of October 1, 2018, through September 30, 2021; and,

WHEREAS, the purpose of this grant is to provide gender specific monitoring of youths showing atrisk factors; and,

WHEREAS, the grant increase does not require local matching funds; and,

WHEREAS, an appropriation is necessary to place the increased grant funds in the proper spending accounts; now therefore.

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the undesignated fund balance of the 2020 Grant Fund:
