## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** awarding a contract for the furnishing of appointment management software for use by the Office of the Clerk of the County Legislature to Q-Less Software of Pasadena, CA, as a sole source purchase, at an actual cost to the County in the amount of \$9,000.00.

**INTRODUCED BY** Charlie Franklin, County Legislator

WHEREAS, the Office of the Clerk of the County Legislature has a need for appointment management software to provide for reduced waiting times and social distancing; and,

WHEREAS, Ordinance 5456, dated November 23, 2020, now pending before the Legislature, would provide funds to allow for the purchase of this software; and,

WHEREAS, pursuant to section 1030.1 of the <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing has determined that this software can be obtained from only one source, Q-Less Software of Pasadena, CA, to ensure compatibility with other County software and ease of maintenance; and,

WHEREAS, this purchase, together with prior purchases of similar software from the same vendor, would bring the total cost of such purchases throughout 2020 to over \$25,000.00, thus requiring legislative approval; and,

WHEREAS, the Director of Finance and Purchasing recommends the award of a contract for the

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make al
payments, including final payment, on the contract.
