IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$175,000.00 from the undesignated fund balance of the 2021 CARES Act Fund to provide COVID-19 testing for unvaccinated Jackson County and 16th Circuit Court associates through the end of 2021 at a cost to the County not to exceed \$175,000.00.

ORDINANCE NO. 5575, November 29, 2021

INTRODUCED BY Charlie Franklin, County Legislator

WHEREAS, required weekly testing of 349 unvaccinated County associates began the week of October 4, 2021, and for an estimated 315 associates of the 16th Circuit Court began on October 25, 2021; and,

WHEREAS, funds from this appropriation will provide for COVID-19 test kits and laboratory services to be utilized by the County through University Health/TMC, under its contract with Sinochips Diagnostics, at \$50.00 per test for up to 664 County and 16th Circuit Court associates though the end of 2021; and,

WHEREAS, an appropriation is necessary to place the funds in the proper spending account; now
