## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$137,016.00 from the undesignated fund balance of the 2021 CARES Act Fund and authorizing the Director of Finance and Purchasing to make a payment in the amount of \$137,016.00 to the Board of Services for the Developmentally Disabled - EITAS to reimburse for expenses incurred in connection with the fight against the ongoing Coronavirus/COVID -19 pandemic.

**ORDINANCE NO. 5584,** December 13, 2021

WHEREAS, U.S. President Joseph R. Biden, Missouri Governor Mike Parson, and County Executive Frank White, Jr., have all declared, in one form or another, the ongoing Coronavirus/COVID-19 pandemic to be a public health emergency; and,

WHEREAS, the County, through its various efforts, plays a significant role in the public health of its citizens; and,

WHEREAS, an appropriate response by the County to this emergency will require significant expenditures from the County CARES Act Fund, which consists of monies provided by the U.S. Treasury for this purpose; and,

WHEREAS, with the funding provided by this appropriation, the Board of Services for the Developmentally Disabled - EITAS will be reimbursed for expenses incurred in connection with the fight against the ongoing Coronavirus/COVID-19 pandemic including legal fees, cleaning supplies, and remote video costs; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
