## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** awarding twelve-month term and supply contracts with one twelve-month option to extend for the furnishing of beer for resale by the Parks + Rec Department to County Beverage Company of Lee's Summit, MO, and Central States Beverage Company of Kansas City, MO, as proprietary purchases.

WHEREAS, the Parks + Rec Department requires contracts for beer with wholesale distributors for the furnishing of beer for resale in departmental retail operations; and,

WHEREAS, the County has contracted with County Beverage Company of Lee's Summit, Missouri, and Central States Beverage of Kansas City (Jackson County), Missouri, since 2017 for the furnishing of these products; and,

WHEREAS, pursuant to section 1030.6, <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing recommends the award of twelve-month term and supply contracts for the furnishing of this commodity to County Beverage Company of Lee's Summit, MO, and Central States Beverage Company of Kansas City, MO, as proprietary purchases of commodities that are to be offered for resale and that are not available on the competitive market; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

agency have been made in the then current Jackson County budget.
