A RESOLUTION awarding a thirty-six month contract for the furnishing of electronic reporting and criminal investigation system subscription services and annual software maintenance for use by the Sheriff's Office to LeadsOnline, LLC, of Plano, TX, at an additional cost to the County in the amount of \$1,878.00 for 2022, and a total three-year cost of \$34,000.00, as a sole source purchase.

WHEREAS, the Sheriff's Office has a continuing need for electronic reporting and criminal investigation system subscription service and software support; and,

WHEREAS, pursuant to section 1030.1 of the Jackson County Code, the Sheriff and the Director of Finance and Purchasing recommend the purchase of annual subscription services and software support for criminal investigations for use by the Sheriff's Office from LeadsOnline, LLC, of Plano, TX, an existing County vendor, at a cost to the County in the amount of \$7,551.00 in 2022, of which amount \$5,673.00 has already been paid, and a total thirty-six month cost in the amount of \$34,006.00, as a sole source purchase; and,

WHEREAS, award as a sole source is appropriate as LeadsOnline is the developer and owner of the needed proprietary software and is capable of providing its maintenance; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as
