### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** approving the settlement of the claims of Teesha C. Miller in the case styled Teesha C. Miller v. Jackson County, Missouri, No. 1816-CV28965, now pending in the Circuit Court of Jackson County, Missouri, for a total payment by the County of \$125,000.00.

WHEREAS, Teesha C. Miller has filed a lawsuit styled Teesha C. Miller v. Jackson County, Missouri, No. 1816-CV28965, now pending in the Circuit Court of Jackson County, Missouri, seeking damages for alleged employment discrimination; and,

WHEREAS, after a thorough investigation and negotiations, the County Counselor recommends a settlement in the amount of \$125,000.00, to be paid by the County to Teesha C. Miller and/or her attorney, Raymond Drake; and,

WHEREAS, the proposed settlement will limit the County's financial obligation in this matter and is in the best interests of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is authorized to settle the claims of Teesha C. Miller in the case styled Teesha C. Miller v. Jackson County, Missouri, No. 1816-CV28965, now pending in the Circuit Court of Jackson County, Missouri, by the total payment of \$125,000.00, in full, final, and complete release of all of her

claims against the County and all of its employees, officers, agents, and servants, as to any damages incurred; and,

BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute any and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to issue a check or checks in an amount totaling \$125,000.00 in full and complete settlement of this claim, payable to Teesha C. Miller and/or her attorney Raymond Drake d/b/a Siro Smith Dickson, PC, pursuant to the specific direction of the County Counselor.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
