AN ORDINANCE appropriating \$63,630.00 from the undesignated fund balance of the 2023 Grant Fund, in acceptance of the State of Missouri Drug Courts Coordinating Commission Family Drug Court Program Grant for use by the Family Court Division.

WHEREAS, the Family Court Division has been awarded the Family Drug Court Program Grant by the State of Missouri Drug Courts Coordinating Commission, for the period July 1, 2023, to June 30, 2024; and,

WHEREAS, the purpose of the Family Drug Court Program is to help substance-abusing offenders break the cycle of addiction and avoid the crimes that often accompany addiction; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made from the undesignated fund balance of the 2023 Grant Fund:
