WHEREAS, the vehicle will be used by the Investigations Division Evidence Unit of the Sheriff's Office to carry equipment and supplies for improved crime scene response; and,

WHEREAS, pursuant to section 1030.4 of the Jackson County Code, the Sheriff and Director of Finance and Purchasing recommend the award of a contract for the furnishing of a new SUV for use by the Sheriff's Office to Joe Machens Ford Lincoln of Columbia, MO, under the terms and conditions of an existing competitively bid State of Missouri Contract No. CC240138008, at an actual total cost to the County in the amount of \$40,325.00; and,


