WHEREAS, by Resolution 20681, dated May 17, 2021, the Legislature authorized the execution of a Cooperative Agreement with ArtsKC to develop and execute a strategic plan for the proposed Arts Council, including, but not limited to, community engagement, infrastructure, and measurement of social and economic outcomes to aid future policy and funding decisions; and,

WHEREAS, ArtsKC submits to the desire of the Legislature to bid for an expansion of their contract in 2024 via an open RFP process to be executed and resolved by the close of 2023; and,

WHEREAS, the execution of an Extension to the Cooperative Agreement, will provide for the implementation and execution of the strategic plan in 2023 at a cost to the County not to exceed \$250,000.00; and,
